Students will be evaluated by one distinguished musician external to VAM.

COMPETITION RULES

1. Applications are subject to a fee of \$20 made payable to the Vancouver Academy of Music.
2. Applicants must prepare one work with accompaniment not to exceed 15 minutes in duration. Applicants are responsible for arranging their own accompanist.
3. One copy of the music must be submitted to the adjudicator (photocopies permitted).
4. The competition will be closed to the public with the exception of the parents/guardians and teacher of the student playing; no video or audio recording permitted. The public is welcome to attend the winners' concert
5. The adjudicator retains the right to withhold any prize if, in their opinion, it is not merited. All decisions made by the adjudicator are final and without appeal.
